



Astrolite® Product Warranty

Bayer MaterialScience Pty Ltd (“Bayer”) warrants that its Astrolite® branded polycarbonate profiled sheet products (Products) will, at the date of purchase, be free from defects due to faulty manufacture or workmanship in accordance with AS4256.5 (Workmanship clause)

Loss of Light Transmission – 7 year Warranty

Bayer warrants that the Products will not lose more than 8% of light transmission for the first 7 years (when tested in accordance with ASTM D1003-07e1- Luminous Transmittance). In the event that a Product fails to comply with this warranty, Bayer will provide a full replacement of the Product, or in the case of a discontinued line, its equivalent.

Weather Breakage – 5 year Warranty

Bayer warrants that for a period of 5 years from the date of purchase the Products (subject to the terms below) will specifically resist damage due to hail measuring up to 25mm in diameter. In the event that a Product fails to comply with this warranty, Bayer will provide a full replacement of the Product, or, in the case of a discontinued line, its equivalent.

Terms

- 1 This warranty is limited to domestic applications and applies to Australian Market Only. Outside of Australia, please refer to your country distributor for applicable Astrolite Warranties.
- 2 The Products must be stored, installed and cleaned in accordance with Bayer’s written instructions which are available at the point of purchase or alternatively from www.bayermaterialscience.com.au.
- 3 This warranty does not apply to damage due to the following causes:
 - (a) Impact of hail measuring greater than 25mm in diameter;
 - (b) Extreme weather conditions, including hurricanes, cyclones, tornados;
 - (c) Accident, vandalism, fire or other like causes; or
 - (d) Failure to comply with Bayer’s instructions for storage, installation and cleaning.
- 4 All claims made under this warranty must be made in writing to the Product Manager, Bayer MaterialScience Pty Ltd, 17-19 Wangara Road, Cheltenham, Victoria, Australia, 3192 and must include a copy of the original purchase documentation or other evidence of the original purchase date.
- 5 Following receipt of a claim made under this warranty, an authorised Bayer representative may choose to inspect the Product and if the claim is accepted, Bayer will retain the damaged Product and provide replacement Product or, in the case of a discontinued line, its equivalent.
- 6 Bayer is not responsible for costs associated with the removal and installation of the Product.
- 7 This warranty is in addition to and in no way limits, varies or excludes any express and implied rights and remedies under any relevant legislation in the country of sale.
- 8 To the extent permitted by law, Bayer cannot be liable for any direct or indirect loss, injury to persons, damage to property, or consequential losses arising from the use of the Product.
